1. The Breeder warrants for 72 hours, this canine to be free of communicable diseases (parvo etc.) at the time the puppy is picked up to go to its new home, and out of my care. Any other reason for return is at the breeder's discretion.

The breeder warrants for the first 12 months from date of birth.

If the dog has to be euthanized for any inherited genetic problems (excluding hip/elbow dysplasia) A puppy of the same sex and quality, selected by the breeder, will be guaranteed to the buyer from another litter, though not necessarily from the same bitch and or sire nor from the next litter due to arrive. If the Purchaser(s) decides that they would like a puppy but it is not the right time for them. They will be placed on a waiting list for 12 months from the time of euthanizing the pup listed above. After the 12 months if no puppy has been replaced, the purchaser agreed to pay any price difference between the puppy listed above and the new puppy.
